Administrator's Report Brett Siefert presented the administrator's report. Immunizations – volume has

been trending higher, in part driven by seasonal flu, RSV, and COVID vaccines; November appears likely to be another record month. PDMP – Missouri will go live with a Prescription Drug Monitoring Program (PDMP) that will supersede the

existing regional PDMP that LCHD has been a member of since 2017; if no

objections, LCHD will sign on to the new PDMP and participate in the necessary

but aggregated data sharing inherent to the PDMP process.

By-laws Annual Review In accordance with the LCHD by-laws, agency by-laws were reviewed and

discussed; no changes sought or motions made and the by-laws will remain

unchanged.

Emergency Account LCHD's latest independent external audit findings include a recommendation to

consider increasing account balance(s) to cover fringe benefit expenses in addition

to payroll. Agency by-laws require that at least payroll expenses be covered.

Malaine Hagemeier moved and Dr. Bockhorst seconded that no funding

modifications be made; motion carried with all in favor.
