Breastfeeding Peer Counselor soon, in the WIC program. Staff have been busy with school open houses, immunizations, and getting the STD/STI testing and treatment program rolling. Environmental staff have been tag teaming with the Department of Natural Resources more lately, presumably in part because of the brisk pace of

construction and some of the related issues.

Other Discussion Discussion arose about the facility roof. While Public Health Fund is the roof's owner,

work around soliciting bids for its replacement will fall to LCHD staff; will it be better to seek bids directly, or to publish a Request for Qualifications (RFQ) for another qualified entity to get bids? Dr. Bockhorst moved and Malaine Hagemeier seconded that an RFQ be used to select a qualified entity to then coordinate gathering bids from contractors for the proposed construction work; motion carried with all in favor in a roll call vote,
