

Lincoln County On-site Septic System Application Process

A permit for construction of an on-site septic system will be <u>denied</u> if there is access to a public sewer system within 300 feet of the property.

To apply for an on-site sewage wastewater disposal system (septic system) construction permit; the application form shall require such information necessary to show that the on-site sewage disposal system will comply with the Missouri Revised Statutes Chapter 701 State Standards. Lincoln County Health Department shall provide technical assistance regarding the type and location of the on-site sewage disposal system to be installed when processing applications received under sections 701.046-701.048 and 701.050. The Lincoln County Health Department (LCHD) has adopted the following application process:

- Is the property: commercial, industrial or a developer of a subdivision? If so, property owners and/or their agent shall first contact the Department of Natural Resources (DNR) Wastewater Program at (573) 751-4817.
- 2. Is the property in a FEMA Flood Plain Area or in an area that may or may not flood regularly? If so, the property owner and/or their agent shall submit a certification letter from the Lincoln County Emergency Management for approval to build in this area, including an on-site septic system. Reach them at (636) 528-6182.
- **3.** Property owner and/or their agent shall obtain a soil morphology evaluation from a qualified Missouri Soil Scientist. **Backhoe pits are required.**
- 4. Choose a <u>Lincoln County on-site septic installer</u>. LCHD recommends a minimum of three (3) bids. A list of licensed Lincoln County on-septic system installers is attached. Construction of an on-site septic system is required by law to be done by a Lincoln County licensed installer. The soil report will determine what kind of system is most suitable for the property. It is important to know and have all property lines clearly marked for your installer to accurately measure set-back distances. Please share plans of any additional structures that may be added to avoid future construction conflict. Property owner and/or their agent may also contact the Health Department to discuss various system possibilities. If you are inclined to install your own system, ask the Lincoln County Health Department (LCHD) for the procedure to be approved.

There is a 3-acre minimum for approved lagoon installation.

5. If your on-site septic system is classified as advanced, an engineered design will be required. Talk with your on-site septic installer or call LCHD.



- 6. <u>Submit Proposal/Pay Permit Fee</u> After a decision has been made on what kind of on-site system and where, the septic installer will submit a permit application to LCHD as well as the \$100 permit fee. Usually, the on-site installer will pay the fee and include it in the bid. Be sure to clarify this with the installer.
- <u>Review Process</u> LCHD will review the permit application and either accept or reject the application within (15) days. During the review process, LCHD will do a pre-site visit to the property. The septic system design shall be marked out for this pre-site visit by the installer. This is to help prevent any changes and delay in the permitting process of the on-site system.
- 8. <u>Permit Issued</u> When the Permit Application is approved and the permit fee is paid, a permit to begin construction is issued to the on-site septic installer. No work may begin until a permit has been issued.
- **9.** <u>Installation Process</u> On-site septic installers must call before 10:00am on each workday of the installation of the on-site septic system. If construction will be done over a weekend or holiday, the on-site septic installer is required to call by 4:00pm of the previous business day.
- 10. <u>Final Approval/Inspection</u> If an inspector is not present during the installation, the installer shall submit a <u>Certification of System without On-site Inspection</u> form completed. The inspector shall mark the final inspection report as "approved" if the on- site septic system was installed as permitted or "not approved" and list any deficiencies in which the system was not installed as permitted. Then a re-inspection will be conducted when the required corrections are made.
